**Homestay Service Agreement**

Homestay accommodation provides students with a safe and secure living environment together with opportunities to learn about Australian culture and to improve their English language ability through everyday situations. For this reason homestay providers are required to provide the required standard of accommodation and quality care.

By signing this service agreement, a homestay provider agrees to abide by the “DECS Code of Ethics and Quality Service Expectations” which details the expected standards and quality of provisions for international students.

I understand I am responsible for providing an environment that is conducive to the student’s successful emotional, social, physical and learning well-being.

I understand and agree to provide duty of care and supervision during all out of school hours which includes weekends, public holidays, school closure and pupil free days and if the occasion arises, when the student/s is unwell.

I understand that an international student may be placed in my care if:

- Criminal History Record Check/s is/are approved
- accommodation meets the required standard and quality
- a suitable (student) match is available

I understand that the placement of a student cannot be guaranteed.

I understand that once a student is placed in my care, they do not have permission to move without prior consent from the school principal.

I understand and accept the right of DECD, through International Education Services (IES) and/or the school, to remove a student from my care.

I understand that my name and contact details will be included on a Public Liability Insurance Register maintained by International Education Services.

I understand that my name, contact and family details will be forwarded (including electronically) to the international student and/or education agent (when a match is made) together with photos (where possible) of the accommodation.
